APPLICATION

On May 31, 2018 (amended July 30, 2018, to increase the number of requested horizontal wells), Verdad Resources, LLC, Operator No. 10651 ("Verdad" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands, for production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations;
 - 2) Approve the drilling of up to four eight horizontal wells within the unit;
- 3) Require that the treated interval of any well be located no closer than 150 feet from the treated interval of any other wellbore producing from the Niobrara, Fort Hays, Codell, and Carlile Formations, and no closer than 600 feet from a unit boundary, without exception being granted by the Director; and
- 4) Require that the wells will be drilled from no more than two surface locations within the unit, or on adjacent lands.

 Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.
