APPLICATION

On May 31, 2018, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Establish an approximate 960-acre drilling and spacing unit for Section 1 and the N $\frac{1}{2}$ of Section 12, Township 2 South, Range 67 West, 6th P.M., for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations in the unit; and
- 2) Approve a total of up to sixteen (16) horizontal wells in the unit, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations; and
- 3) Provide that the productive interval of any horizontal well shall be no closer than 460 feet from the boundaries of the unit and not less than 150 feet from the productive interval of another well within the unit, and authorize up to one (1) well pad within the unit or adjacent thereto, unless an exception is granted by the Director; and
- 4) Find that an approximate 960-acre drilling and spacing unit for the development of the Codell and Niobrara Formations on the Application Lands will prevent waste, protect correlative rights, and maximize the efficient and economic production of the Codell, Carlile and Niobrara Formations on the Application Lands; and
- 5) For such other findings and orders as the Commission may deem proper or advisable in this matter.
