APPLICATION

On July 17, 2018, CCRP Operating, Inc. (Operator No. 10665) ("CCRP" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Vacate the approximate 640-acre drilling and spacing unit established by Order No. 535-69 for Section 27, Township 8 North, Range 59 West, 6th P.M., for production of oil, gas and associated hydrocarbons from the Niobrara Formation.
- 2) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands, and approving the drilling of 14 horizontal wells within the proposed unit, for the production of oil, gas and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations, with the treated interval of any horizontal well permitted under this Application located not less than 300 feet from unit boundaries and not less than 150 feet from any other well producing or drilling from the Niobrara, Fort Hays, Codell, and Carlile Formations, without exception being granted by the Director.
- 3) Limit the drilling of any permitted wells under this Application to no more than four multi-well pads within the drilling and spacing unit, or on adjacent lands with surface owner consent, without exception being granted by the Director.

• COGCC Rule 318.a. provides that for any oil or gas well drilled to a common source of supply and drilled to a producing depth at least 2,500 feet below ground surface shall be located not less than 600 feet from any leaseline and not less than 1,200 feet from any other producing or drilling oil or gas well when drilling to the same source of supply, unless authorized by Commission order upon hearing. The Application Lands are subject to this Rule for production of oil and gas from the Fort Hays, Codell, and Carlile Formations. Section 34, Township 8 North, Range 59 West, 6th P.M., is subject to this Rule for

production from the Niobrara Formation.

On September 19, 2011, the Commission entered Order No. 535-69 which, among other things, established an approximate 640-acre drilling and spacing unit for Section 27, Township 8 North, Range 59 West, 6th P.M., and approved the drilling of two horizontal wells within said unit, for production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of any permitted well located not less than 600 feet from unit boundaries and no closer than 150 feet from any other well drilling or producing from the Niobrara Formation.

Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
