APPLICATION

On August 8, 2018, Bison Oil & Gas II, LLC (Operator No. 10661) ("Bison" or "Applicant"), filed a verified amended application pursuant to §34-60-116, C.R.S. for an order to:

1) Modify Order No. 535-956 insofar and only insofar as to the unit boundary setback of the established drilling and spacing unit for the Application Lands to allow the productive interval of each authorized well within the unit to be located no closer than 300 feet from the unit boundary, but maintain the setback between the productive interval of the authorized wellbores at 100 feet, unless an exception is granted by the Director.

APPLICABLE ORDERS AND RULES

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.
- On September 19, 2011, the Commission entered Order No. 535-69, which established 40 approximate 640-acre drilling and spacing units for certain lands in Townships 7, 8, and 9, North, Ranges 58 through 60 West, 6th P.M., and approved two horizontal wells within each unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara Formation, with the treated interval of the wellbore for the permitted wells to be no closer than 600 feet from the unit boundaries, without exception being granted by the Director.

- On March 19, 2018, the Commission entered Order No. 535-956, which vacated Order No. 535-69 as to Section 18 and established an approximate 1,280-acre drilling and spacing unit covering the Application Lands for production of oil, gas and associated hydrocarbons from the Niobrara, Ft. Hays, Codell, and Carlile Formations and authorized up to 20 horizontal wells within the unit with the productive interval of each wellbore to be located no closer than 600 feet from the unit boundary, and no closer than 100 feet from the productive interval of any other wellbore located within the unit, unless an exception is granted by the Director.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of September 3, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
