On July 19, 2018, Kerr-McGee Oil & Gas Onshore LP (Operator No. 47120) ("Kerr-McGee" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in three approximate 720-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. White 35-4HZ Well (API No. 05-123-46949) - Niobrara Formation - WSU #1.
- b. White 35-5HZ Well (API No. 05-123-46946) - Codell Formation - WSU #2.
- c. White 35-6HZ Well (API No. 05-123-46947) - Niobrara Formation - WSU #3.
