## **APPLICATION**

On July 20, 2018, Edge Energy II, LLC (Operator No. 10671) ("Edge" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Modify the 460-foot unit boundary setback established in Order No. 535-834 to allow the productive interval of each approved horizontal well within the unit to be located no closer than 300 feet from the unit boundary, but maintain the setback between the productive interval of the approved wellbores at 150 feet, unless an exception is granted by the Director.

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.
- On July 24, 2017, the Commission entered Order No. 535-834 which established an approximate 1,301.24-acre drilling and spacing unit for Section 30, Township 8 North, Range 65 West, 6<sup>th</sup> P.M., and Section 25, Township 8 North, Range 66 West, 6<sup>th</sup> P.M., and approved a total of up to twelve horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations with the productive interval of the wellbore of any permitted wells in the unit shall be located no closer than 150 feet from the productive interval of any other wellbore

located in the unit, and no closer than 460 feet from the unit boundaries, unless the Director grants an exception.

Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of September 3, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention. Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
