At this time, DOE does not request any additional information but would encourage COGCC to place general language in the permit such that the company would accommodate DOE sampling requests in the future. DOE agrees with the COGCC assessment that the pad is located approximately

1.15 miles from the Rulison site on an existing pad located at NSW Section 26 7S 95W, and the bottom-hole-locations range approximately from 1.08 to 1.31 miles from Project Rulison. From the locations provided all wells fall under the Tier 2 sampling and monitoring of the COGCC Rulison Sample and Analysis Plan and are located in Sector 10 of the Rulison SAP. DOE will continue to review the proposed locations and subsurface orientations of the propose drilling for documentation when sampling occurs. 


