The well pad has been constructed, there are no producing wells on this location; there is currently no drilling rig on this pad. Drilling operations are projected to commence sometime in 2010. Since the last permit was filed, there have not been any changes in the lease or mineral situation and surface location. The well pad will not need to be altered. A semi-closed loop system will be used. Per GarCo Vacation Ordinance dated 10-5-1987, CR 213 is now OXY's private property north of Sec 8, 7S, 97W, 6 PM. Oxy will comply with new "Notice to Operators" regarding reserve pits (June 12, 2008).
