Operator must implement best management practices to contain any unintentional release of fluids.

Location is in a sensitive area because of shallow groundwater; therefore production pits must be lined.

Location is in a sensitive area because of shallow groundwater; therefore either a lined drilling pit or closed loop system must be implemented.
