Based on site specific conditions evaluated within the context of topography, geography, nature of operations and proximity to surface water, APC will implement BMPs in accordance with good engineering practices to mitigate the potential for impacts to surface water from an unintentional discharge of fluid. There will be 4 new drills and the Helmer Getz Unit #1 well going into the tank battery.
