Please be advised that Berry Petroleum Company will be re-filing permits with the Colorado Oil and Gas Conservation Commission for the above-referenced wells.

Berry Petroleum Company has opted to re-file 4 wells original permitted while adding 2 additional well permits to the location in order to bring all wells on the pad into regulatory compliance with the COGCC Oil and Gas Location Assessment (Form 2A). By doing so, all previously permitted/newly permitted wells on the M15 pad will have a two year expiration date, instead of 1 year.

- This is an existing pad with 10 wells:
  - 4 wells have been drilled to TD and are currently waiting on completion,
  - 4 wells have been previously permitted but are not drilled,
  - 2 wells are new permits.
- The pad has been built.
- No pit is required as Berry Petroleum Company uses a total closed loop system.
- Conductors have been set on 4 wells
- No rig is on-site at this time.
- The location does not require a variance from any of the rules listed in Rule 306.d. (1). (A).(ii).
- The location is not in a restricted surface occupancy area.
- The location is not in a sensitive wildlife habitat area.

Pursuant to Rule 305 and 306, the enclosed notification is required as part of the permitting process. Please sign and date where indicated and return to my attention.




