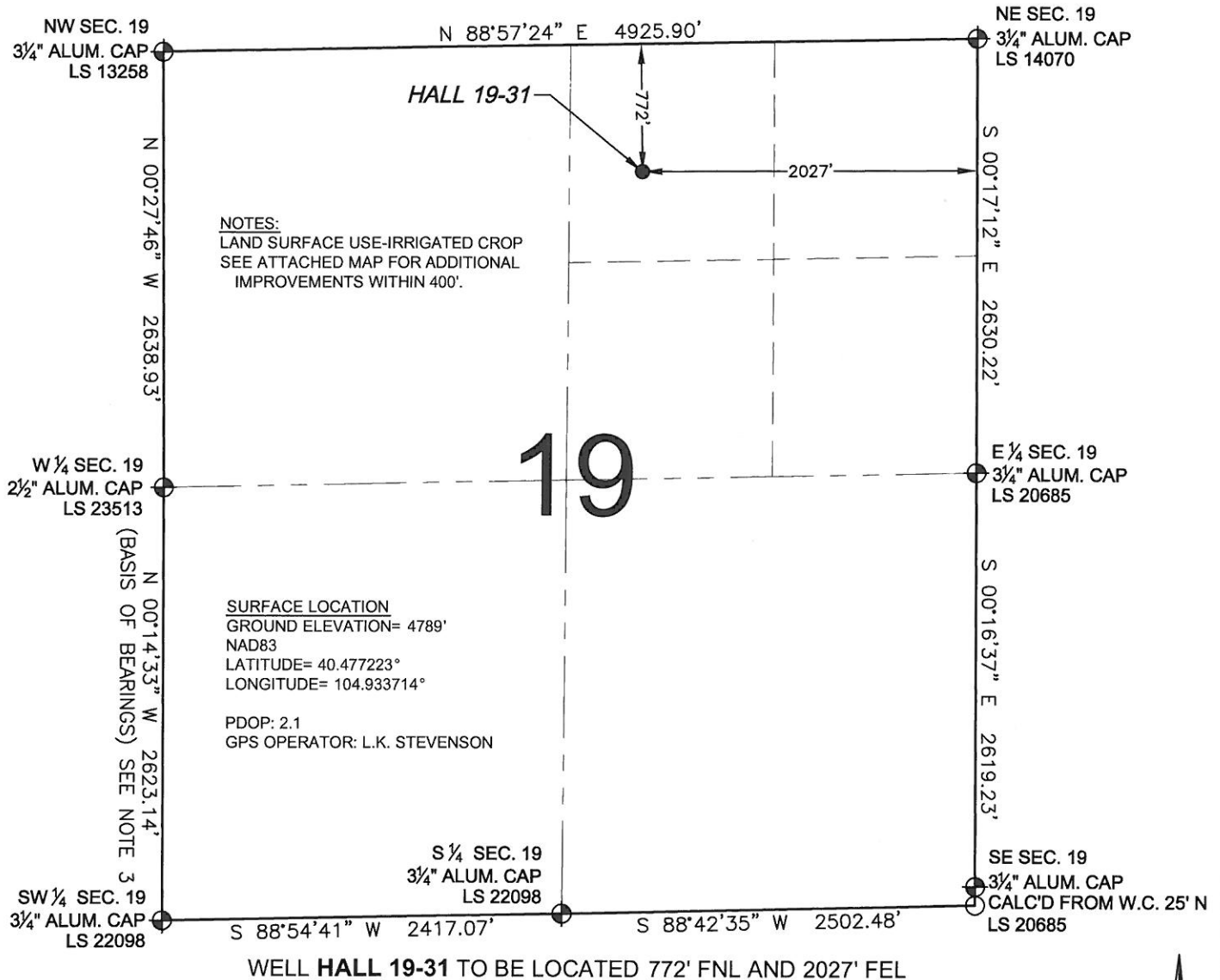


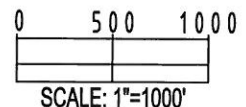
WELL LOCATION CERTIFICATE: HALL 19-31
