KP 423-17 was just drilled and the drilling rig is still on pad. No completions have been done. it will not have a wellhead installed until after the rig leaves. There is no pressure on the Production casing. Bradenhead builds to 150 psi in 3 hrs 41 mins. When open the bradenhead bleeds to 0 psi in 46 seconds. 2 gallons cement and gas escapes. No flow once bled down.
