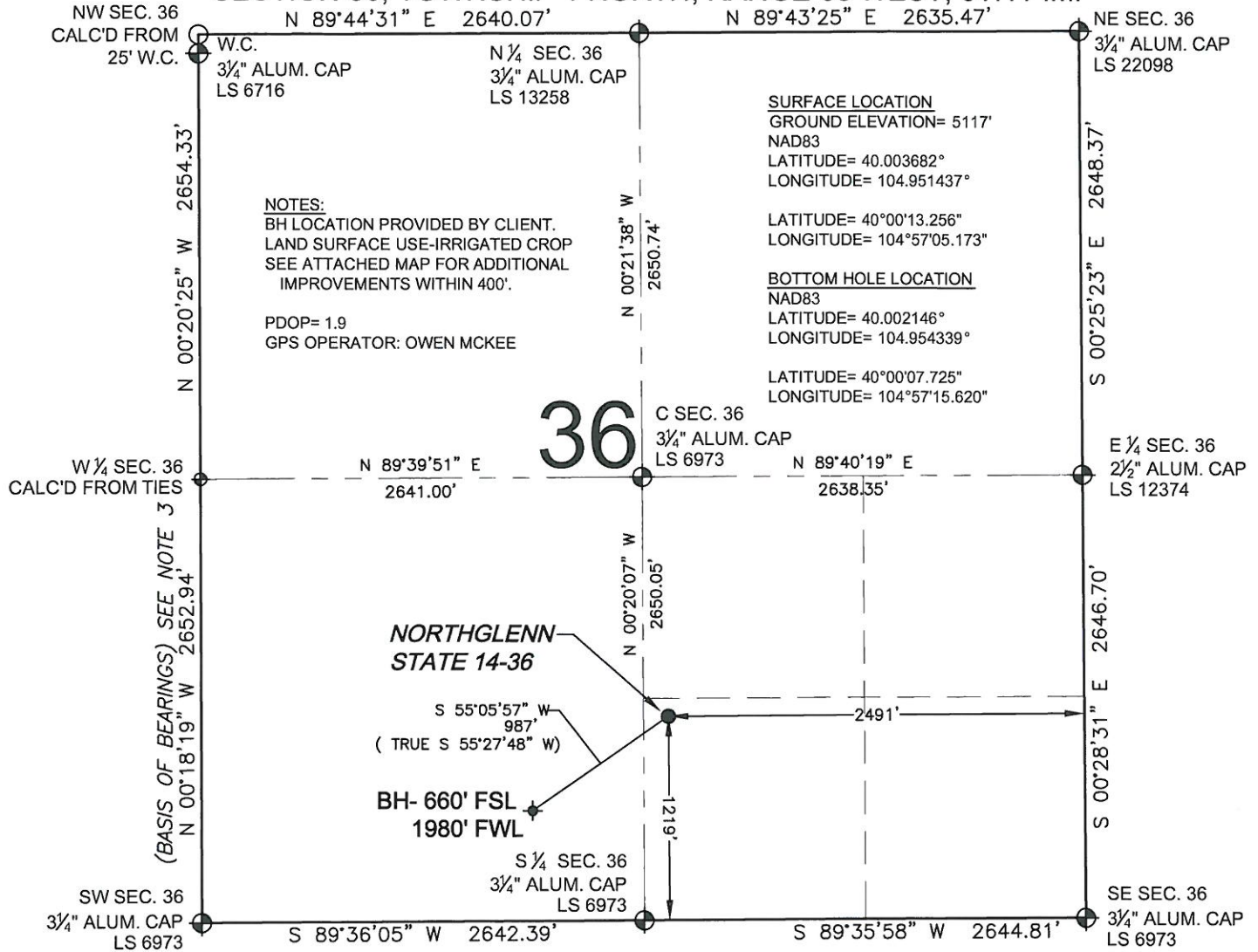


# WELL LOCATION CERTIFICATE: NORTHGLENN STATE 14-36
