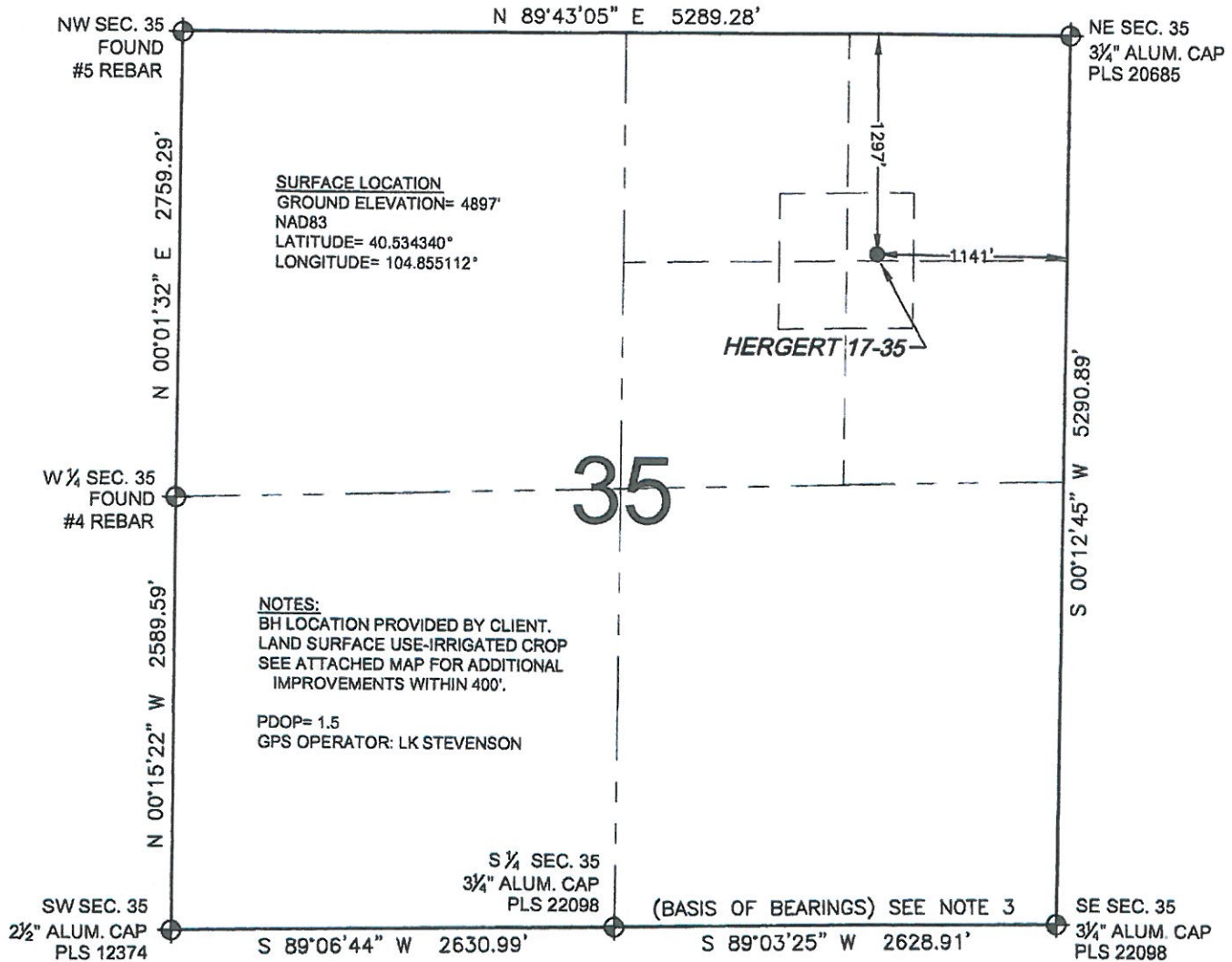


WELL LOCATION CERTIFICATE: HERGERT 17-35

BH = BOTTOM HOLE

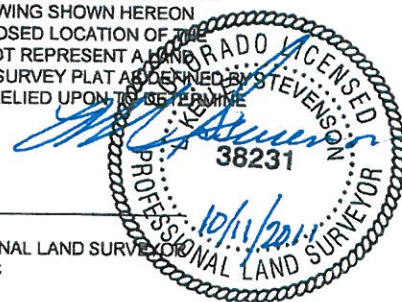
