

## **MEMORANDUM OF SURFACE AGREEMENT**


This Memorandum shall provide notice to all parties that Kerr-McGee Oil & Gas Onshore, LP, a Delaware limited partnership, and Hidden Creek Development LLC, a Limited Liability Company, have entered into an agreement dated July 5, 2011 (the "Agreement") covering the lands described on Exhibit A to this Memorandum.
