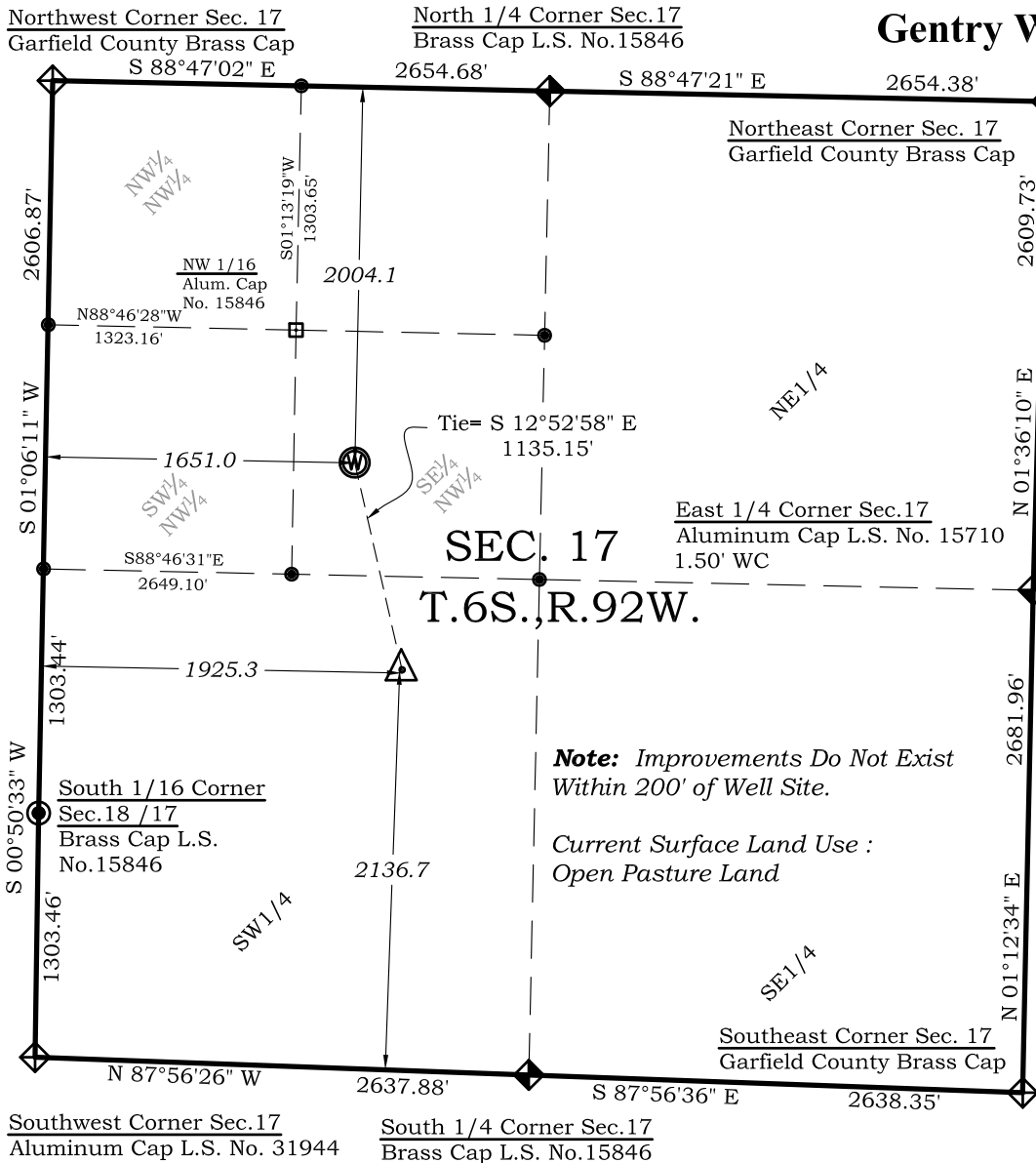


# Well Location Plat Gentry Well B7

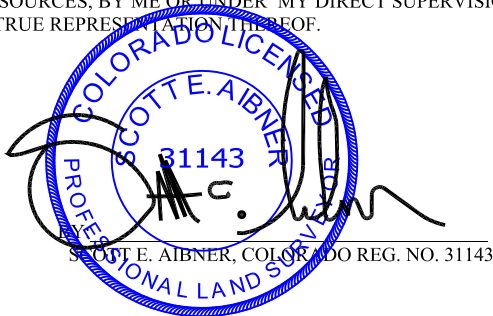
