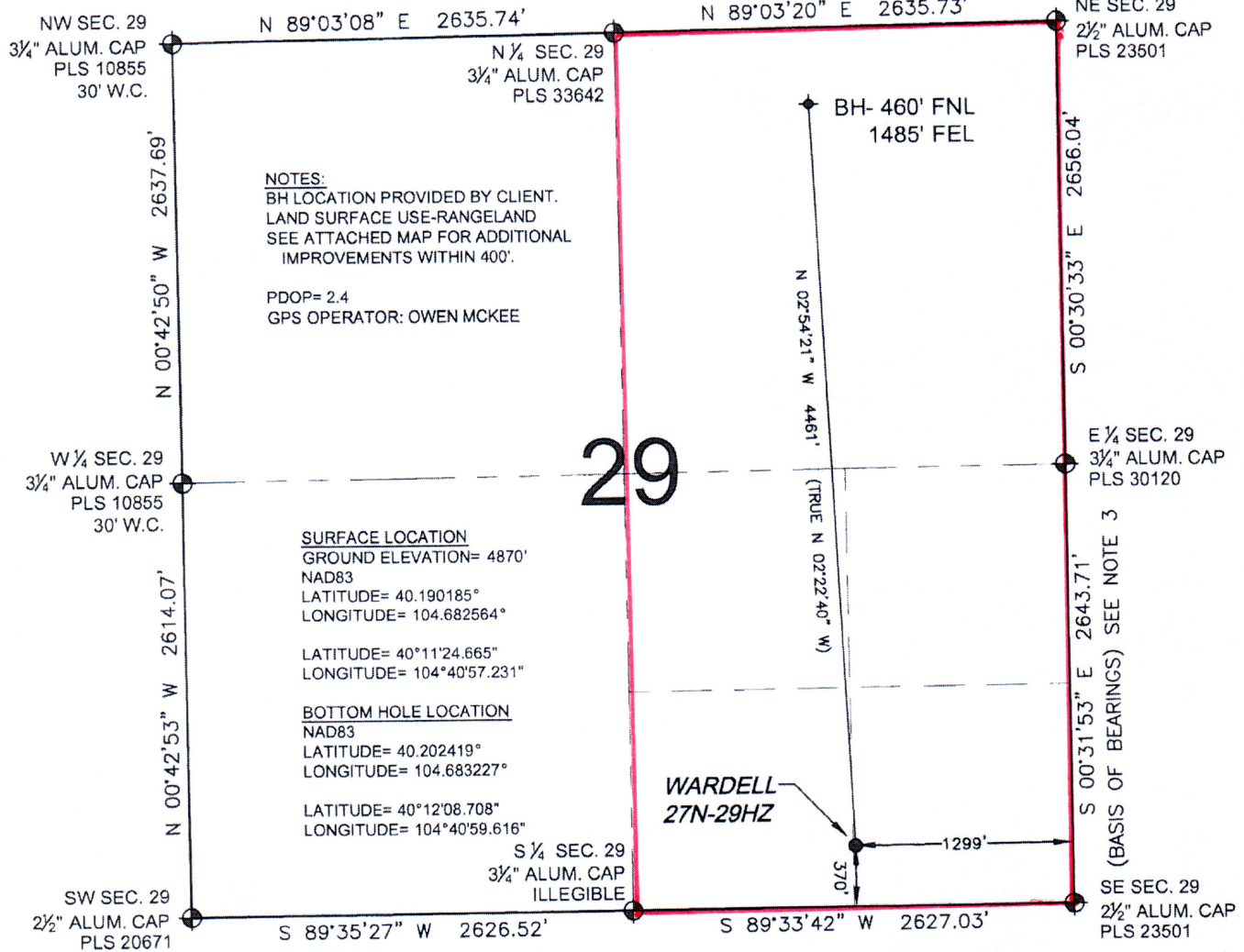

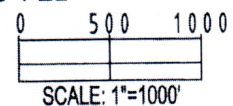
WELL LOCATION CERTIFICATE: WARDELL 27N-29HZ

- ◆ = EXISTING WELL

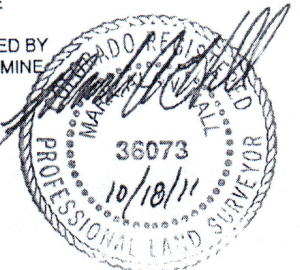
