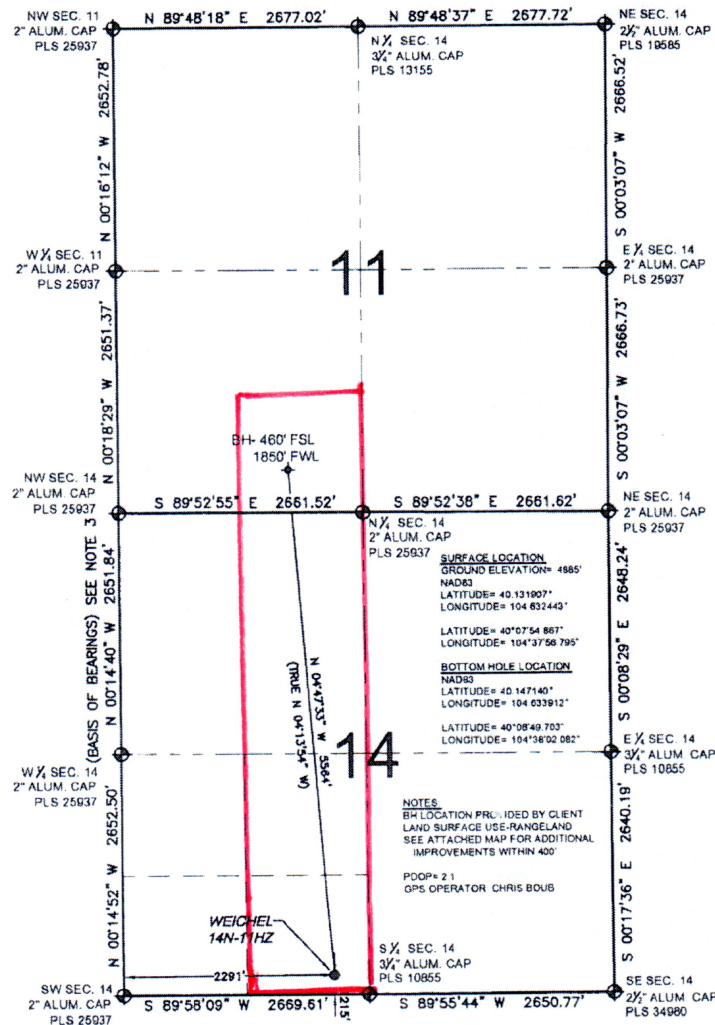

WELL LOCATION CERTIFICATE: WEICHEL 14N-11HZ

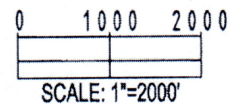

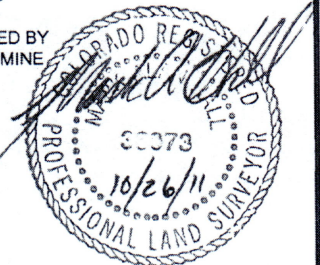
