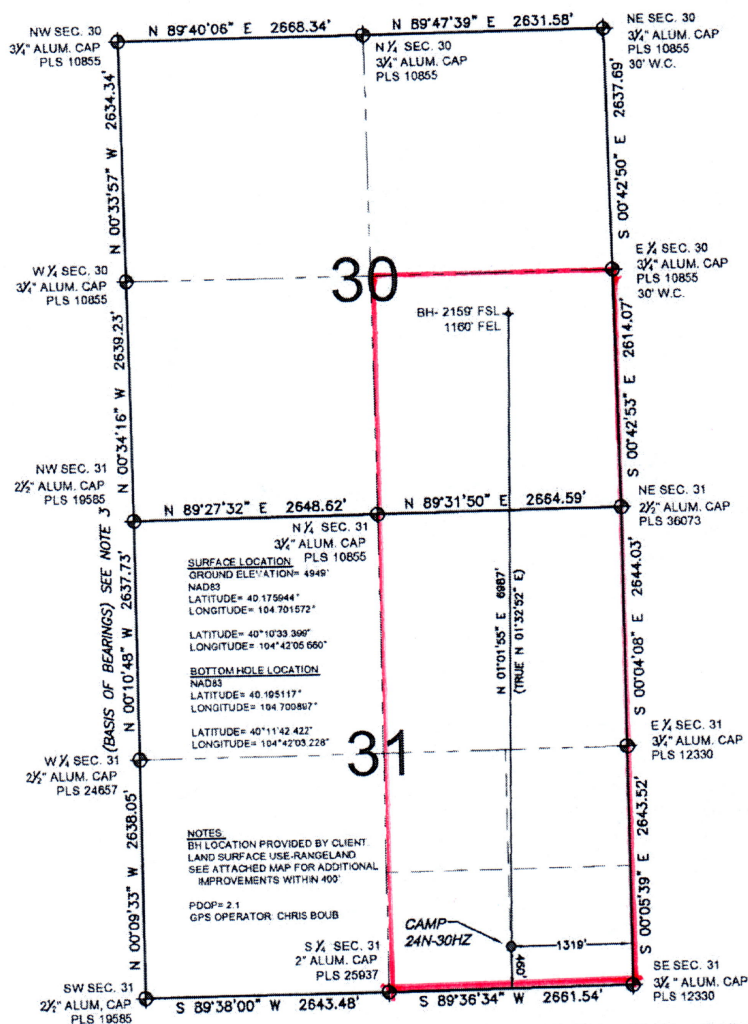

WELL LOCATION CERTIFICATE: CAMP 24N-30HZ

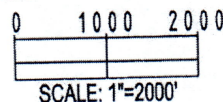

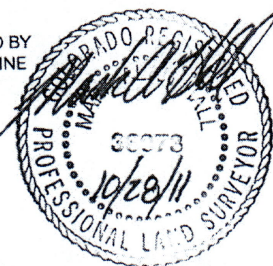

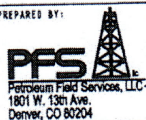
