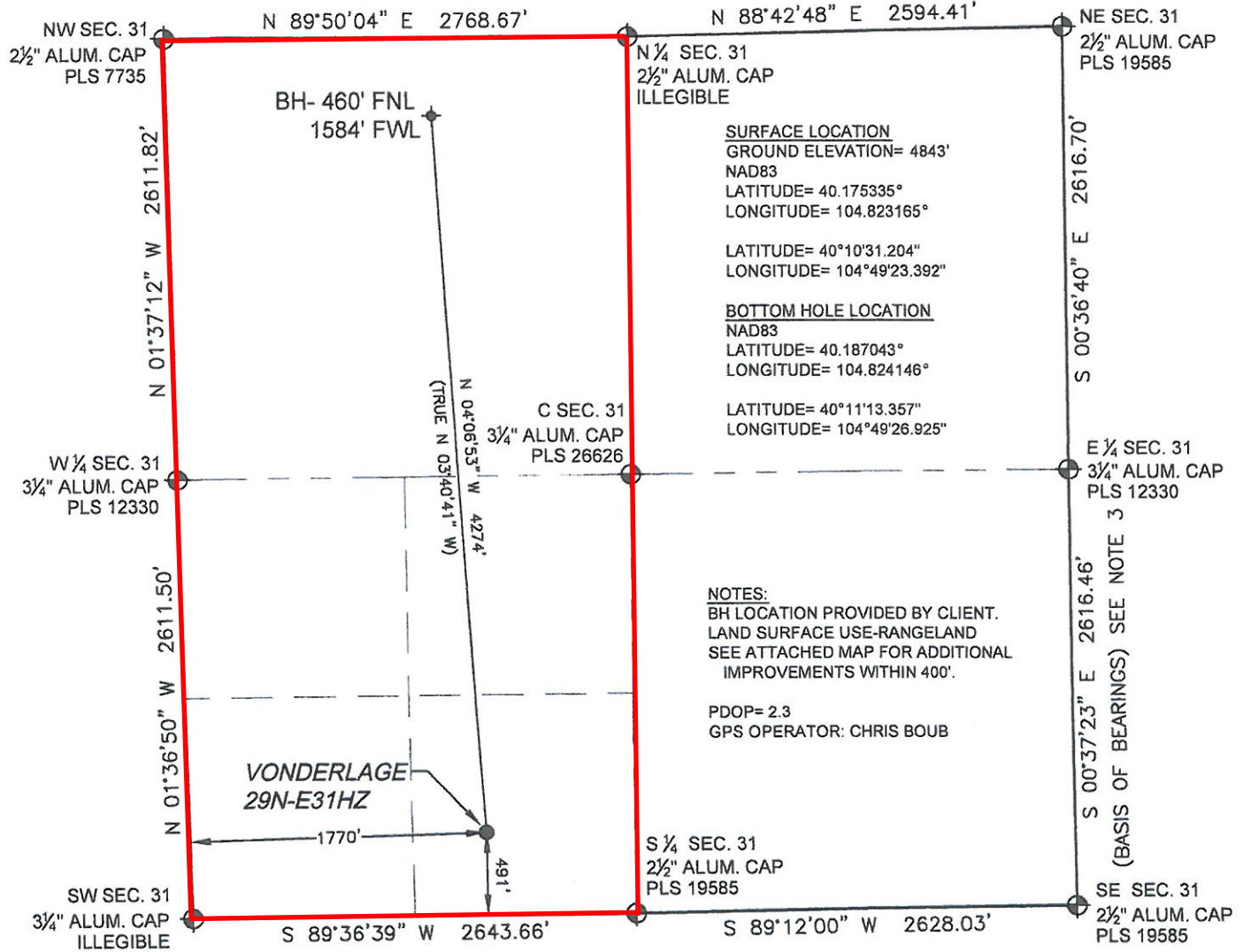

PROPOSED SPACING UNIT

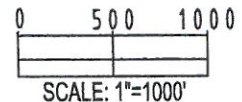
WELL LOCATION CERTIFICATE: VONDERLAGE 29N-E31HZ
