This well was originally perforated twice, on 7/21/06 (2,855'-3,266' - 180 shots/0.450 diameter) and again on 8/7/06 (2,916'-3,278' - 228 shots/0.410 diameter) resulting in perms from 2855'-3278' as shown in the current wellbore diagram. The original completion report and wellbore diagram were incorrect, in that they only included the perms for 8/7/06.

The top of the Fruitland formation is at 2,271' MD. (Please see attached cross section diagrams)
