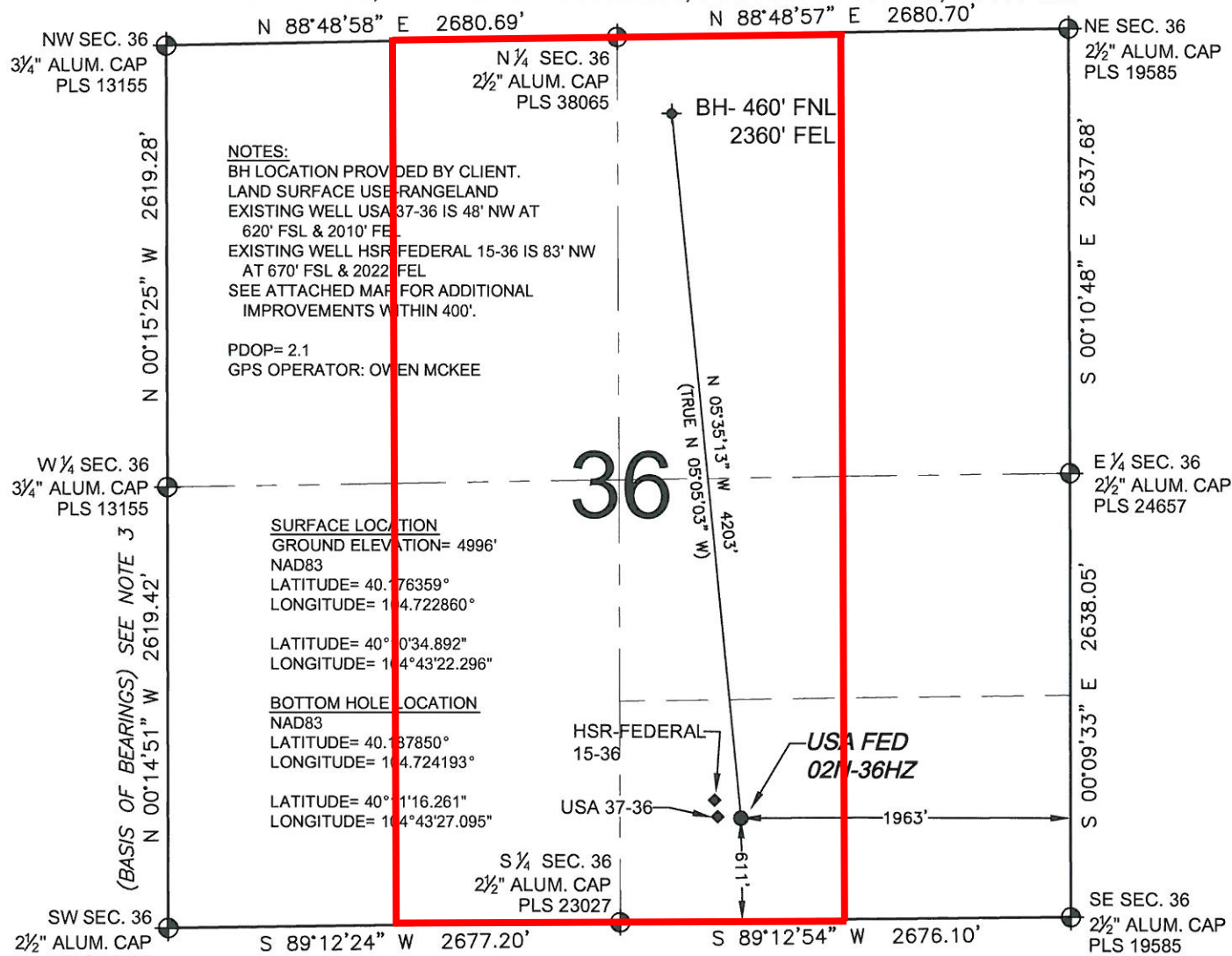

WELL LOCATION CERTIFICATE: USA FED 02N-36HZ

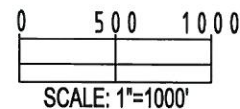
