

MEMORANDUM OF  
SURFACE DAMAGE AGREEMENT WITH HORIZONTAL DRILLING

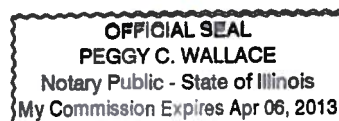
