Flowline was exposed in order to replace the section that leaked. 50 cu yds of impacted soil was transported to Buffalo Ridge Landfill and the site was backfilled with clean fill dirt.

How was the extent of contamination determined? Site is scheduled to be further excavated and assessed with a geo probe rig to determine the extent of groundwater impact.
