- It is the Surface Owner's intent that this release is a general release which shall be effective as a bar to each and every claim, demand or cause of action it releases. The Surface Owner recognizes that the Surface Owner may have some claim, demand or cause of action against the Released Parties of which the Surface Owner is totally unaware and unsuspecting that the Surface Owner is giving up by execution of this release. It is the Surface Owner's intention in executing this release that it will deprive the Surface Owner of each such claim, demand or cause of action and prevent the Surface Owner from asserting it against the Released Parties.
