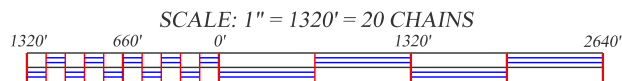

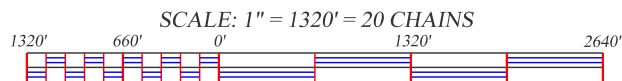
# EXHIBIT I-A-3: WELL LOCATION PLAT (3 of 4)

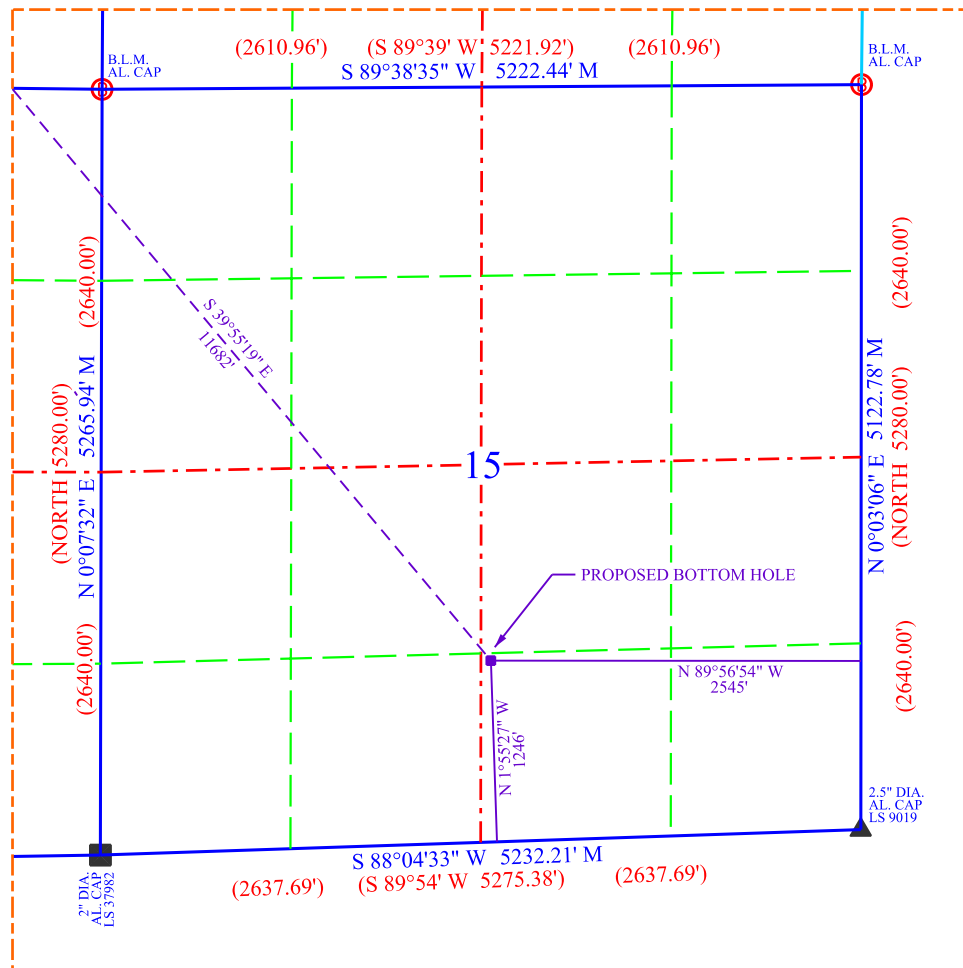

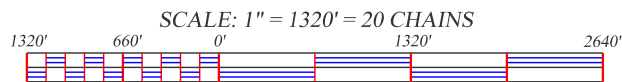
