Encana is requesting to decommission and remove the remediation equipment and abandon the system wells from the West Divide Creek Seep site. Encana will continue quarterly groundwater monitoring for BTEX (EPA method 8260) and methane (RSK-175) at monitoring wells MW-2, MW-4, MW-8, MW-12, MW-17, MW-20, and MW-22. The next scheduled sampling event will be July 2014.

Encana is requesting approval to decommission the remediation system and abandon the system wells for the West Divide Creek Seep site. Encana will continue to perform quarterly groundwater monitoring at wells MW-2, MW-4, MW-8, MW-12, MW-17, MW-20, and MW-22 for BTEX (EPA 8260) and methane (RSK 175). Attached are the last two quarterly monitoring reports. Well MW-17 has now been below the standard for benzene for two quarters. The benzene concentrations are lower in April 2014 for MW-2 and MW-4 than April 2013. Continued MNA is recommended.

	Continue quarterly groundwater monitoring for BTEX (EPA method 8260) and methane (RSK-175) at monitoring wells MW-2, MW-4, MW-8, MW-12, MW-17, MW-20, and MW-22 and provide updated monitoring reports on a quarterly basis.
	Visual monitoring and observations will be made and recorded along West Divide Creek from surface water monitoring station DCS-1 to DCS- 8 during groundwater sampling activities and other routine site visits.
