Ward Petroleum Corporation (Ward) hereby requests that the Director grant an exception location to Colorado Oil and Gas Conservation Commission (COGCC) Rule 318A.(a) and Rule 318A.(c), for the above referenced well. The surface location, pertaining to the Application for Permit to Drill (APD), does not conform to COGCC Rule 318A.(a) order due to surface owner request and topography. The preferred location was agreed upon by Ward and the surface owner through multiple conversations and meetings.

Due to surface owner request and topography, the well has been placed to accommodate a mutli-well pad to reduce surface disturbance. The surface owner has agreed to the placement of the well. Please find the attached waiver from the surface owner.

The above referenced well is a boundary well and does not conform to Spacing Docket 407-1038. Ward proposed the following spacing unit: N2/N2 of Sec. 14; S2S2 of Sec. 11 T1S R67W – 240 acres.


