Engineer	The current wellbore configuration (production casing TOC at 2525' with uncemented annulus from 2525' to the surface casing shoe at 325') is not compliant with Rule 209 (protection of coal seams) and Rule 317.d., which requires "The casing program adopted for each well must be so planned and maintained as to protect any potential oil or gas bearing horizons penetrated during drilling from infiltration of injurious waters from other sources, and to prevent the migration of oil, gas or water from one (1) horizon to another, that may result in the degradation of ground water." The Fox Hills, Lance, Fort Union, and the bottom portion of the Wasatch Formation are uncemented with the potential for cross flow of fluids between formations.	8/21/2014 10:15:55 AM
