

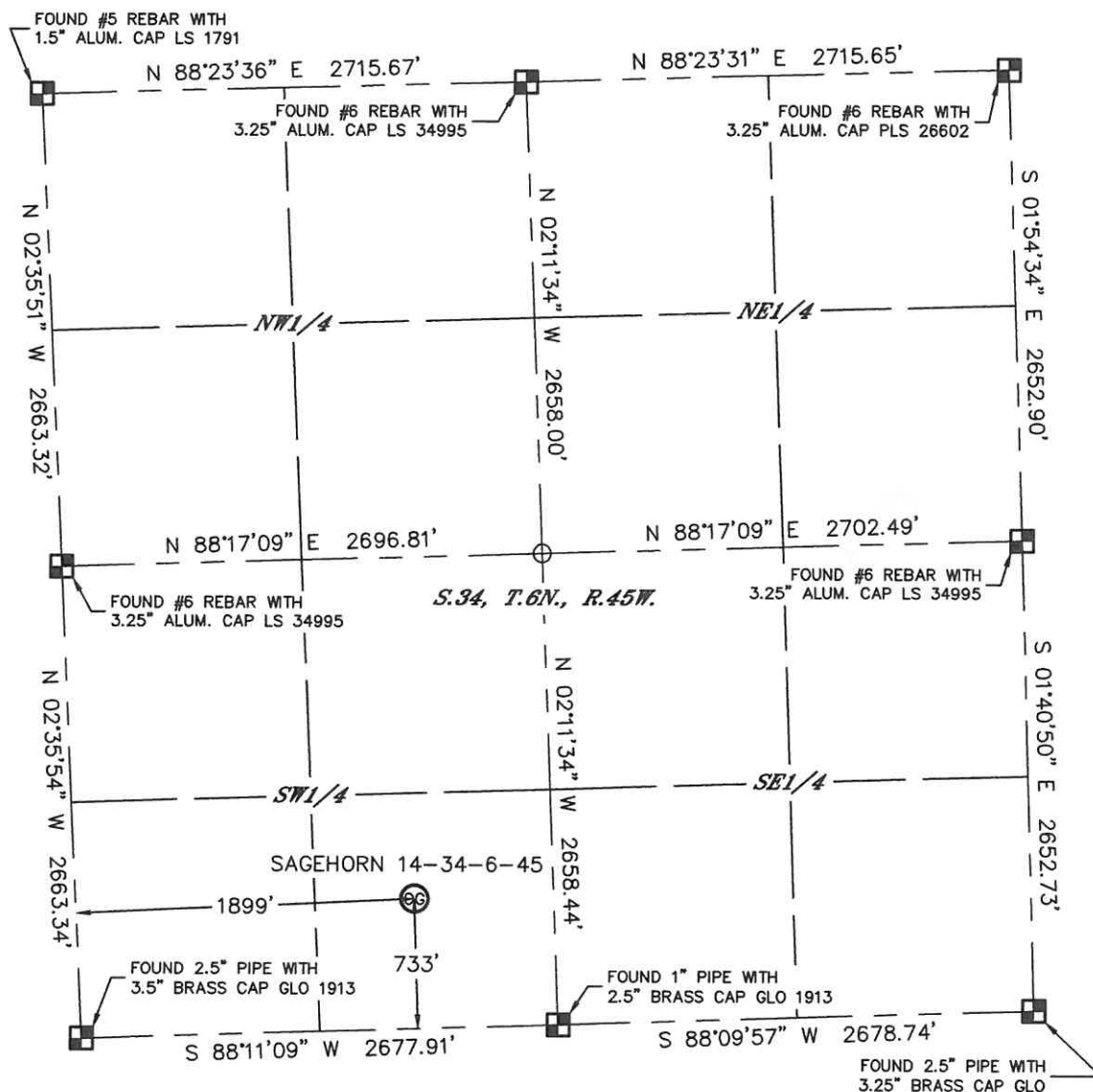

Lat40°, Inc. has determined the surface location of the SAGEHORN 14-34-6-45 to be 733' from the SOUTH line and 1899' from the WEST line as measured at right angles from the section lines of Section 34, Township 6 North, Range 45 West of the Sixth Principal Meridian, County of Phillips, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 8/14/2014, for and on behalf of OMIMEX PETROLEUM, INC. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
