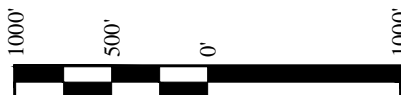

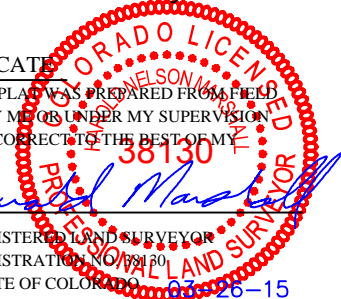
### BASIS OF ELEVATION
