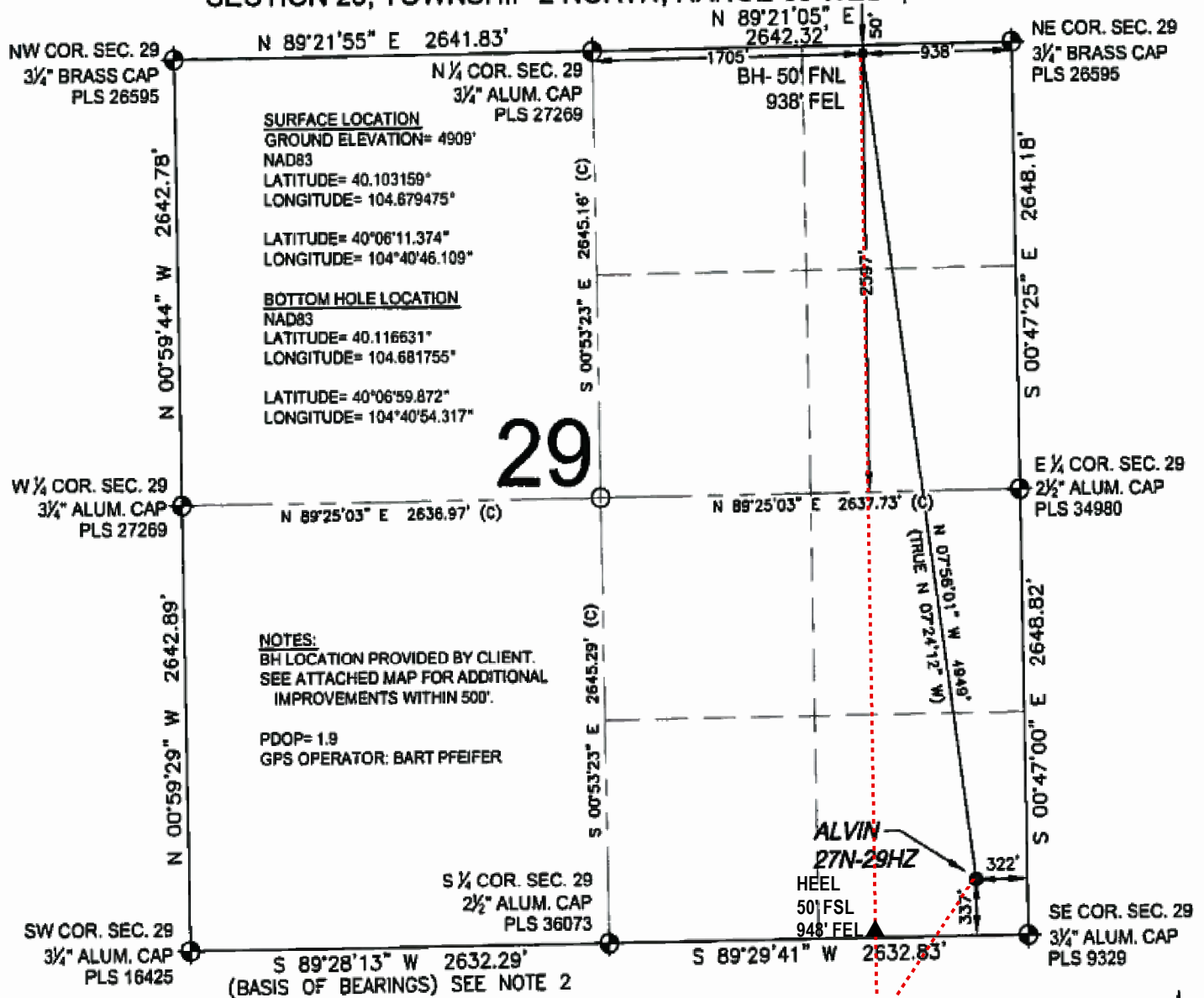


WELL LOCATION CERTIFICATE: ALVIN 27N-29HZ

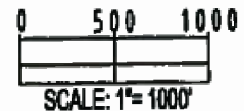

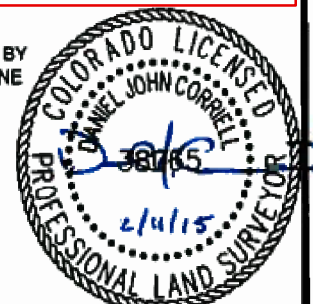

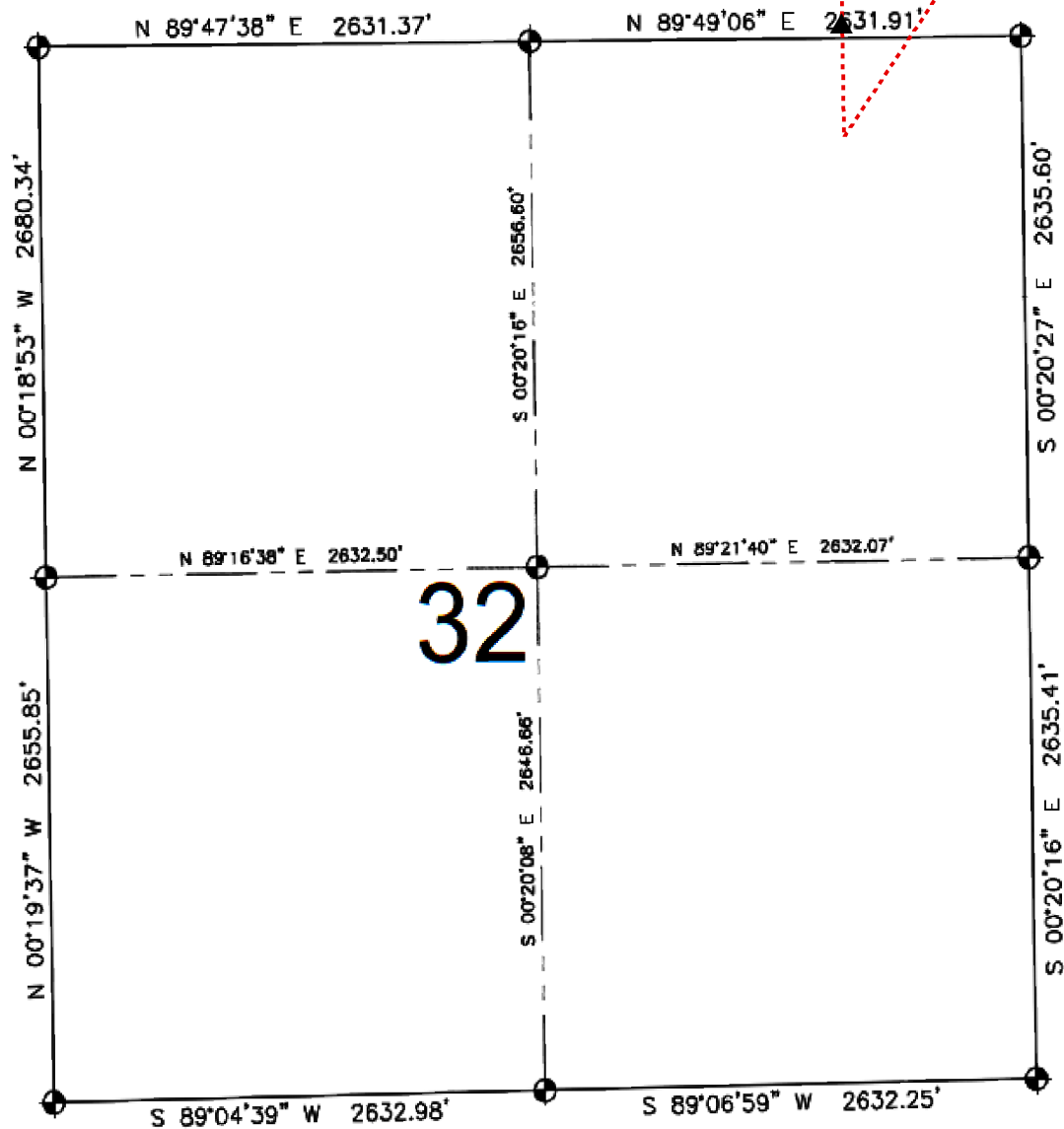
