Comments:

This well was drilled during our 2008 drilling program and it was temporarily abandoned due to drilling problems. BP has recently restarted our drilling program and this well is a sidetrack candidate. We are currently conducting additional geological and reservoir studies in this area to inform proper horizontal lateral placement which would allow the most efficient access to the upper undeveloped coal seams. Since additional time is needed to complete these studies, BP respectfully requests that interim reclamation be deferred for this location. Should drilling of the sidetrack not commence by August 30, 2016, BP will perform interim reclamation at this location. BP has been controlling weeds and stormwater at this location as per COGCC conditions of approval. Attached to this request is a map depicting the stormwater controls that are in place and a map depicting the interim reclamation area.
