Details: This well was originally drilled and abandoned in 09/11/2001. There is no production casing in this well, only surface casing. Back in 2001 this well was drilled and while they were running casing they hit a tight spot at 391' which is suspected to be parted 8-5/8" casing. It was decided to P&A after several trials of getting past the parted surface casing failed.

Purpose is to re-enter and adequately replug prior to hydraulic stimulation of proposed horizontal well per DJ Basin Offset Policy dated December 16, 2013.
