COMMENTS:

In lieu of an option 1 or 2 required by the Jacobucci 32K-243 (API#05-123-41170) and Jacobucci 32O-203 (API# 05-123-41184) APD COAs, PDC requests approval for Option 4 remediation on this well for the purposes of PDC's Jacobucci project frac's. We intend to proceed with the followoing procedure:

1. Run CBL from 7900'-Surface
2. If TOC meets COGCC requirements, we intend to pull tubing, set a CIBP 50' above top J-Sand perms and install a 5K wellhead
3. If TOC does not meet the minimum of 300' above top of Niobrara we intend to proceed with the following:
 - a. Shoot squeeze holes 10' +/- above existing TOC
 - b. Shoot upper squeeze holes in appropriate area to meet COGCC requirement of 300' above Niobrara formation top (7210')
 - c. Set CICR @7225'
 - d. Calculate cement needed on 9" open hole with pipe
 - e. Sting in to CICR and pump away calculated cement volume
 - f. Displace cement within 2 bbls of EOT
 - g. Sting out and displace 2 Bbls on top of CICR- pull tubing out
 - h. SI well until Jacobucci frac's are complete
