1. Rig up, install BOP and test
2. Pull rods, pump and tubing
3. Run 3-7/8" bit and proceed to EZ drill cement retainer at 7950'
4. Cleanout to EZ Drill cement retainer at 8014', circulate wellbore clean
5. Pull tubing and bit
6. Run workstring and 4-1/2" packer to ~7920' and acidize Dakota perforations 7967-8006'
7. Release packer and TOOH with tubing and packer
8. TIH tubing, rods and pump
9. Rig down and clean location
