**Comments:**

Well was drilled and completed in November 2004. Well was subsequently tested in January 2005 with no success. Well never produced and was P&A in January 2006. As there was never any production, no tank battery facility was constructed (see attached aerial photo from 2005). Following P&A operations, all equipment was removed and the wellsite re-contoured. The landowner or tenant farmer has resumed farming this area (see attached aerial photos from 2011, 2013 and 2015).
