The pit materials that have been excavated and tested for complete remediation will be placed back in the pit. If required or deemed appropriate, additional native backfill consisting of locally imported material will be placed in the excavation. The backfill material will be compacted using the excavator or similar piece of equipment. The excavation will be completely backfilled to ground surface and re-contoured to match pre-existing surface conditions. The surface will be re-seeded using a local seed mix recommended/approved by the property owner.
