Lot 5 of section 35 is not part of this lease, therefore the distance to the lease line is correct at 174'. Spacing order 479-12 doesn't create a unit for section 35, therefore there is no unit boundary, unit acreage or unit configuration. Operator agrees and those figures have been removed. Engineer	Offset water well check: COGCC evaluated offset water wells within one mile of this proposed well's surface hole location. This information was used in addition to locally-available geophysical logs and hydrogeologic information to evaluate the adequacy of the operator's proposed surface casing setting depth.
