To Whom It May Concern:

In accordance with the Colorado Oil and Gas Conservation Commission ("COGCC") Rule 305.a.(2), BP America Production Company ("BP") hereby provides notice that a permit to conduct Oil and Gas operations relating to the above well is being sought by BP. You are receiving this notice because you are the owner of a Building Unit within one thousand feet of the proposed well and associated production facilities. The proposed facility is an expansion of the Carmelita Gallegos A 1 pad. The expansion will include a wellhead with artificial lift and associated equipment.
