All permitted water wells within the search radius show zero for reported depths. Depths to formation tops in offset oil and gas wells, locally-available geophysical logs, and hydrogeologic information was used to evaluate the adequacy of the operator's proposed surface casing setting depth. Operator's geologic prognosis indicates the proposed surface casing will cover the entire Green River formation.</p> <p>Offset Well Evaluation: Evaluated offset PA well Chevron #TR 332-21-597 (API#045-12270). Original wellbore was sidetracked due to fish and casing was not set in the 00 or 01 wellbores. Both wellbores were plugged back with cement with adequate coverage above the Mesaverde top.
