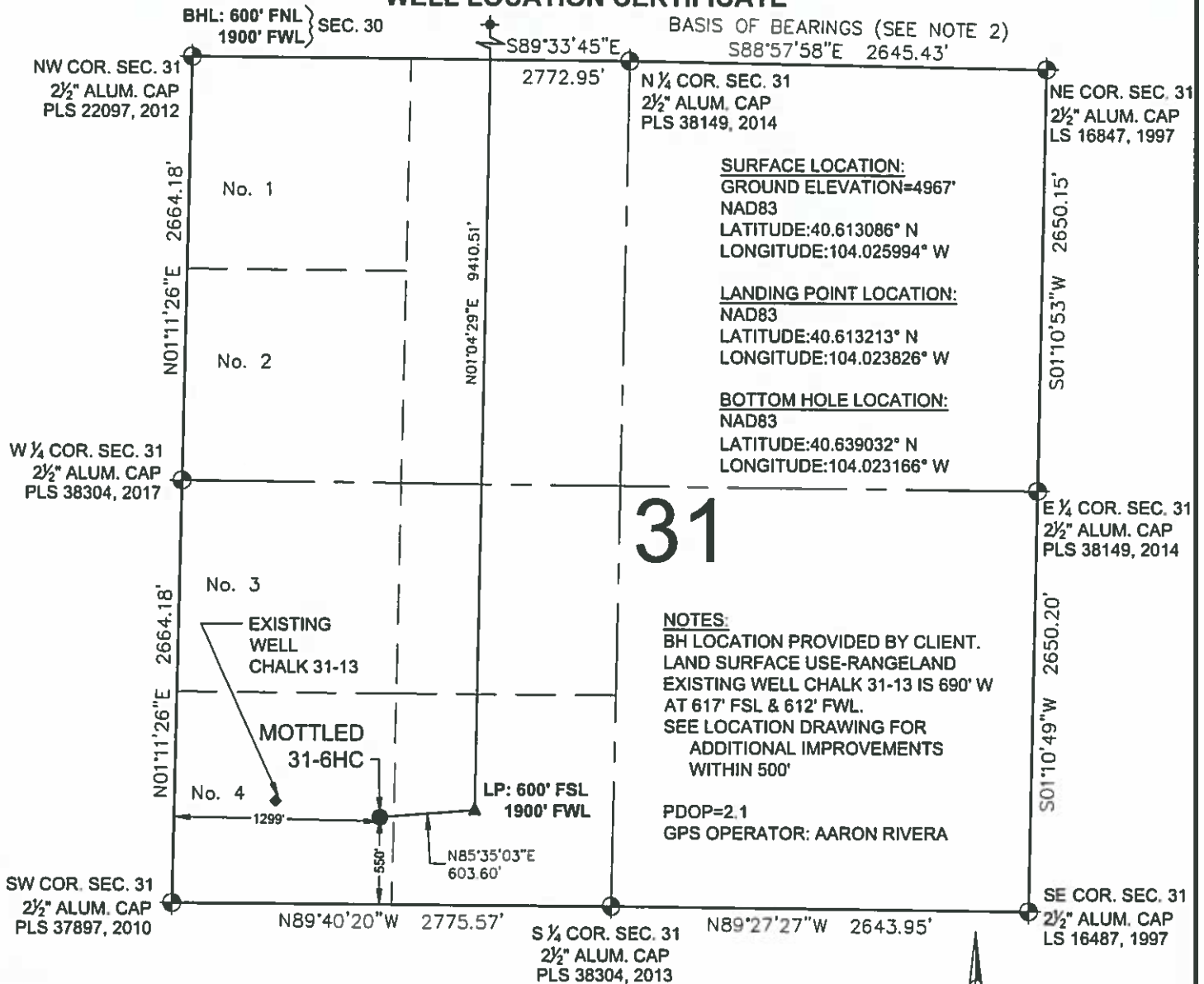


MOTTLED 31-6HC WELL LOCATION CERTIFICATE

- ALL DISTANCES AND BEARINGS SHOWN HEREON ARE GROUND VALUES AS GPS MEASURED IN THE FIELD, WITH TIES TO WELLS MEASURED PERPENDICULAR TO SECTION LINES. THIS LOW DISTORTION PROJECTION (LDP) IS BASED ON THE NORTH AMERICAN DATUM OF 1983, U.S. SURVEY FOOT WITH A LATITUDE ORIGIN OF 40.655085°N, A CENTRAL MERIDIAN LONGITUDE OF 104.086861°W, AND A SCALE FACTOR ON THE CENTRAL MERIDIAN OF 1.000232 (EXACT). THE LDP BASIS OF BEARINGS IS GEODETIC NORTH.

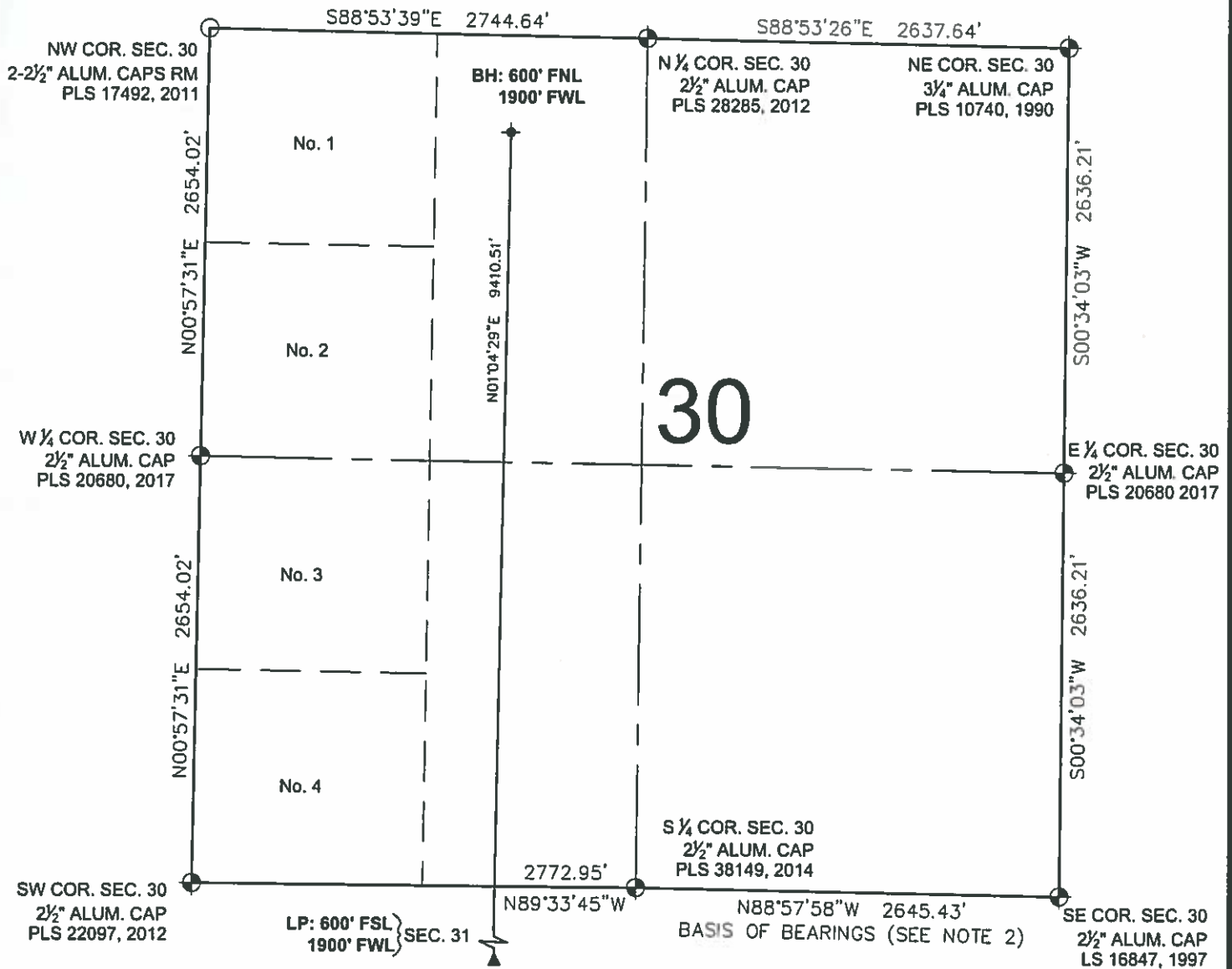
