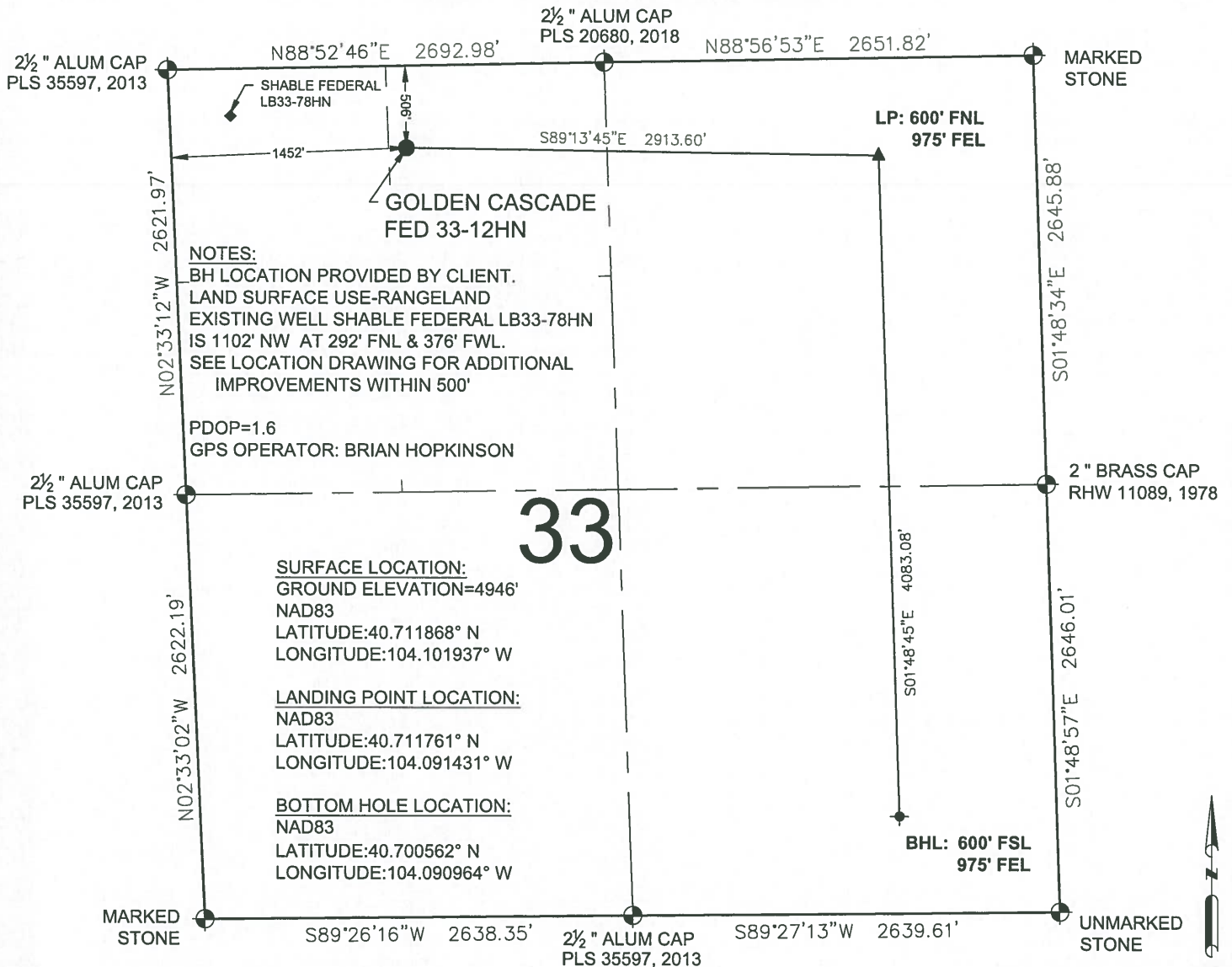


GOLDEN CASCADE FED 33-12HN WELL LOCATION CERTIFICATE
