	1) Submit Form 42 electronically to COGCC 48 hours prior to MIRU for the first well activity with a rig on the pad and provide 48 hour spud notice via Form 42 for all subsequent wells drilled on the pad. 2) Comply with Rule 317.j. and provide cement coverage from TD to a minimum of 200' above Niobrara. Verify coverage with cement bond log.

Notice will be given to all offset operators within 150 feet prior to drilling.
2	Drilling/Completion Operations	Renegade will run at minimum an Open-hole Resistivity Log with Gamma Ray Log from TD to the surface casing of this vertical wellbore. This will verify the setting depth of the surface casing and any aquifer coverage. A Cement Bond Log with Gamma-Ray will be run on production casing from TD to 300' above top of cement. The Form 5, Completion Report, will list all logs run and have those logs attached.
