This location does not meet reclamation requirements. Multiple pipe risers remain on the North and South end of the location. Original corrective action has not been addressed.

Additionally, various concrete and asphalt debris observed on bare areas to the west end of the location.

Corrective Action:

Perform reclamation in accordance to COGCC 1000 series reclamation requirements and remove riser equipment and various debris remining on locaiton.
