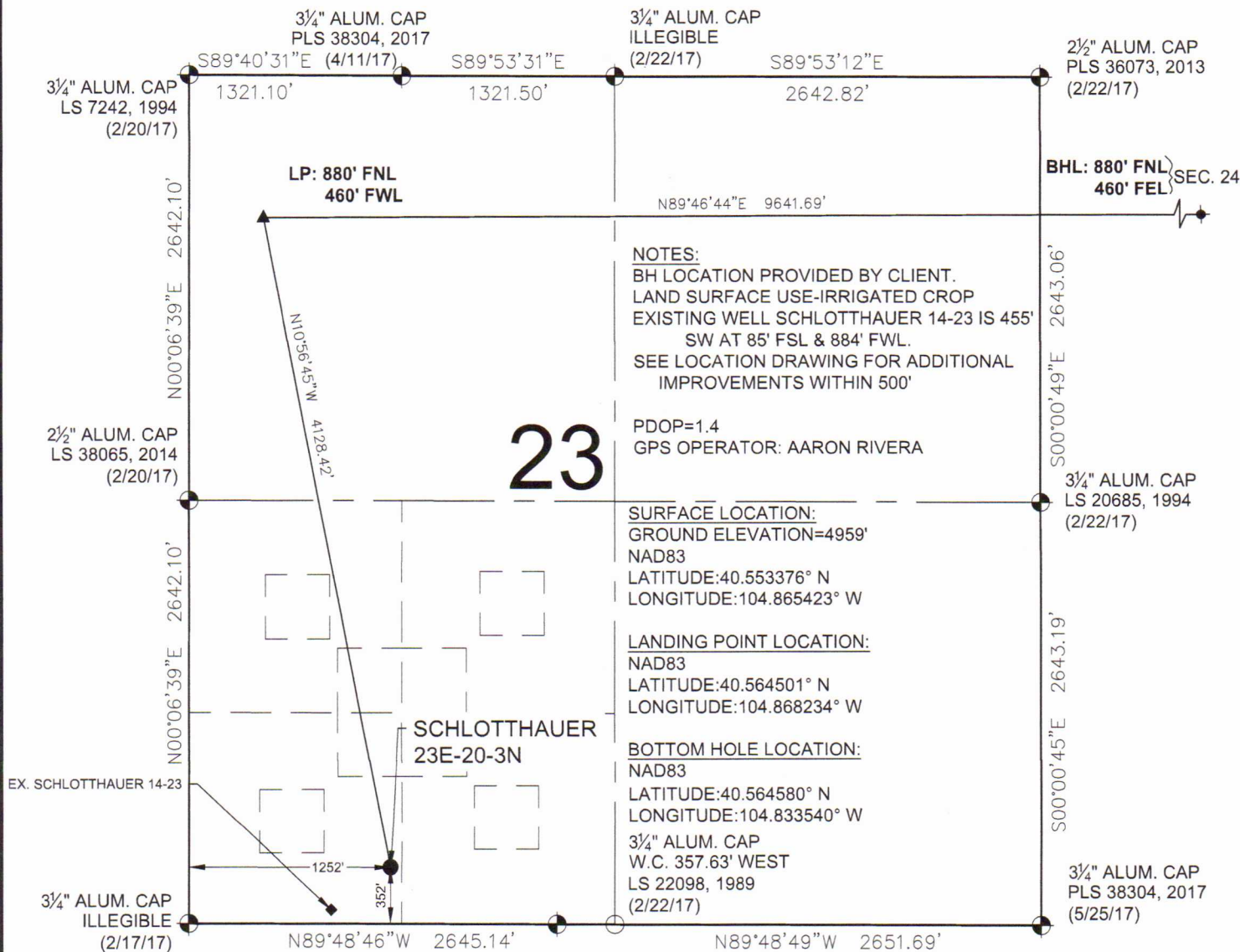








**SCHLOTTHAUER 23E-20-3N

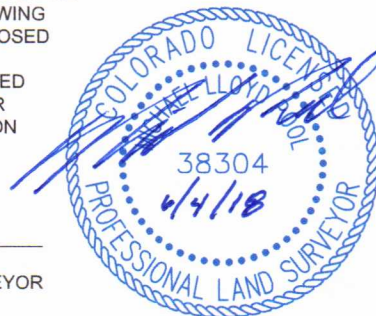
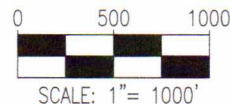

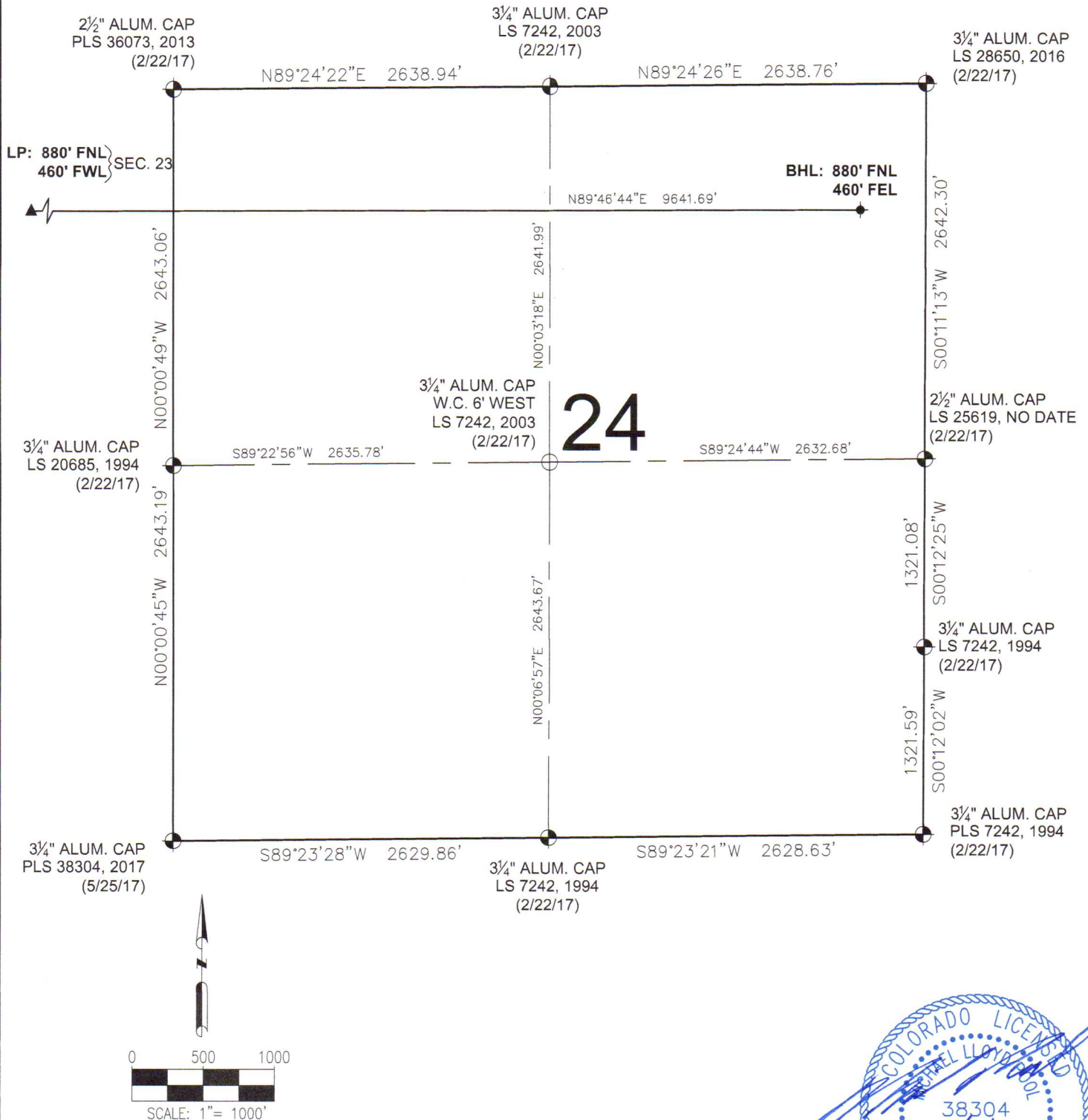
