Dear Mr. Raner,

The Colorado Oil and Gas Conservation Commission (COGCC) received your complaint regarding odor and noise from an oil and gas location in the vicinity of your residence on 07/22/2018. Your complaint is recorded in document number 200446047 and can be reviewed via the "Complaints" link, on our website (<http://cogcc.state.co.us/>).

The actions taken to address your complaint are summarized below.

- On 07/24/2018 a COGCC inspector conducted an inspection of the Sack 21-4-12HC location, operated by Extraction Oil & Gas Inc. (documented in Field Inspection Report [FIR] # 691300413);
- During the inspection wind speeds were too high to permit a sound survey;
- The inspector returned to the location on 07/26/2018 and conducted a sound audit. The sound audit determined the average noise level was 56.2 decibels, which is in compliance with the maximum permissible sound levels established in COGCC Rule 802 for the activities occurring at the location; and
- The inspector did not detect any odors on or off of the location. The inspector referred your odor complaint to the Colorado Department of Public Health and Environment Air Pollution Control Division (CDPHE APCD). I have included their contact information below.
