SRC Energy (SRC) is planning to drill the following horizontal wells as follows:

Chalk-Seeley 7-26 Pad: SWNE Section 26 -T6N-R66W
Weld County, Colorado

The surface locations of SRC's proposed wells have been staked outside of the COGCC Rule 318A.a. Greater Wattenberg Area (GWA) Drilling Window and are being permitted as exception locations. In addition, under the COGCC Rule 318A.c. any new Twinning well is to be located within 50 feet of an existing well. SRC's proposed wells are located greater than fifty feet from the nearest Oil & Gas well. SRC Energy is the surface owner and waives these exceptions for 318A.a and 318A.c and no separate waivers are required.
