Ladies and Gentlemen,

SRC Energy Inc. (SRC) is applying for permits to drill the captioned horizontal wells.

Pursuant to Rule 317.s, no portion of a proposed wellbore's treated interval shall be located within one hundred fifty (150) feet of an existing (producing, shut-in, or temporarily abandoned) or permitted oil and gas wellbore's treated interval belonging to another operator without the signed written consent of the operator of the encroached upon wellbore.
